

Trofile is a cell-based approach to determine a patient's HIV co-receptor tropism (or "Tropotype"). Trofile uses the complete gp160 coding region of the HIV-1 envelope protein ensuring that all of the determinants of tropism are tested. In-house validation data indicates that Trofile is sensitive to detect 0.3% CXCR4 using minor variants. Subtype is determined based on the HIV-1 gp41 envelope region. This test is validated for testing specimens with HIV-1 viral loads equal to or above 1000 copies/mL and should be interpreted only on such specimens. This test was developed and its performance characteristics determined by Laboorp. It has not been cleared or approved by the Food and Drug Administration. Monogram Biosciences, Inc. is a subsidiary of Laboratory Corporation of America Holdings, using the brand Laboorp. The results should not be used as the sole criteria for patient management.
