Interpretation:

Oral azithromycin doses of 250 to 500 mg produce peak serum concentrations of 0.2 to 0.7 mcg/mL approximately 2 to 3 hours post dose. Weekly doses of 1200 mg produce proportionally larger concentrations. Some accumulation may occur over the first week of treatment, so concentrations should be obtained at steady state (15 days or more of daily treatment).

The azithromycin tablet and oral suspensions may be given with or without food.

If the time of the dose and the blood draw were not accurately recorded, accurate interpretation of the concentration is not possible.
