0.1 S/CO (Ref Interval: <=0.8)

INTERPRETIVE INFORMATION: T. cruzi IgG, Recombinant Antigen

0.8 S/Co or less ..... Negative - No significant level of Trypanosoma cruzi IgG antibody detected.

0.9 1.1 S/Co ..... Equivocal - Questionable presence of Trypanosoma cruzi IgG antibody detected. Repeat testing in 10-14 days may be helpful.

1.2 S/Co or greater ..... Positive - IgG antibodies to Trypanosoma cruzi detected, which may suggest current or past infection.

0.1 IV (Ref Interval: <=1.0)

INTERPRETIVE INFORMATION: T. cruzi IgG, Purified Antigen

1.0 IV or less.....Negative - No significant level of Trypanosoma cruzi IgG antibody detected.

1.1 IV.....Equivocal - Questionable presence of Trypanosoma cruzi IgG antibody detected. Repeat testing in 10-14 days may be helpful.

1.2 IV or greater...Positive - IgG antibodies to Trypanosoma cruzi detected, which may suggest current or past infection.

According to the CDC, at least two different serologic tests should be used to make the laboratory diagnosis of chronic Chagas Disease, as no single serologic test is sufficiently sensitive and specific. If results between the two assays are discrepant, repeat testing or testing by a third method may be helpful.

This assay should not be used for blood donor screening or associated re-entry protocols, or for screening Human Cell and Cellular Tissue-Based Products (HCT/PS).
